

Everything is busting with life as Spring dominates the Stonewood area. However, the criminal element will always be on the prowl. Make sure your doors and windows are secured. Do not hide spare keys in mailboxes and/or under doormats. Illuminate all darkened areas around your residence and use motion lights if you can afford them. Make sure all vehicles, storage buildings and residences are always secured as well as bicycles, toys, and other items. Be aware of scams from unlicensed contractors offering to do work for you by checking with the City of Stonewood for license status (304-623-2919). When your residence is unattended for days at a time, have someone to pick up your mail and maintain the residence. Always, if you observe someone suspicious or suspicious activity, please dial "911".

Covid-19 Tips

Covid-19 and variant precautions: Please sanitize your hands before wearing masks. Make sure it covers both your nose, mouth, and chin. After removing your mask, store it in a plastic container and wash it every day. Don't use masks with valves. Always wash your hands with disinfectant when touching items in public. Try not to touch your face until you are sure your hands are sanitized.

Jogging Tips

When jogging, there are safety in numbers. Carry your ID! Do not run with your phone or other valuables in sight and avoid devices that may distract you. Avoid jogging after dark in poorly lit areas. Jog in familiar places but vary your route. Wear bright colored clothing to improve your visibility. Avoid using MP3 players and cell phones while jogging. These devices distract victims from being aware of their surroundings and make you a prime target for the criminal element.

Officer Roger Cunningham (504) has 25 years of law enforcement experience. A graduate of the 99th basic class at West Virginia State Police Academy and a graduate of Glenville State College with a 4-year BA degree, Officer Cunningham has served in many capacities. He was a substitute teacher for Marion County schools, a former member of the Marion County Sheriff's department-where he served 12 years- and head of the Marion County Court Security. He is a certified SWAT member and Deputy First Class. Officer Cunningham joined the Stonewood Police Department in August of 2021.



Officer R.G. Matheny, II (503) is a graduate of the 143rd Basic Class- West Virginia State Police Academy. Matheny has been a certified law enforcement officer since 2010, receiving two Sherlock Holmes awards and a Medal of Merit. Matheny is an active member of the Fraternal order of Police since 2011 and elected in 2019 to serve as President of the Fraternal Order of Police, Lodge 78. - * IF YOUR FIRE ESCAPES, YOU ARE LIABLE FOR THE COSTS OF FIGHTING THE FIRE AND ANY DAMAGE THE FIRE MAY CAUSE TO OTHERS.
